READ CAREFULLY BEFORE USING

The Public Health Service Act (Section 308 (d)) provides that the data collected by the National Center for Health Statistics (NCHS), Centers for Disease Control and Prevention (CDC), may be used only for the purpose of health statistical reporting and analysis. 3. Not link this dataset with individually identifiable data from other NCHS or non-NCHS datasets.
