NN: Not nationally notifiable – This condition was not designated as being nationally notifiable.

NP: Nationally notifiable but not published – CDC does not have data because of changes in how conditions are categorized.

Cum: Cumulative year-to-date counts.

Med: Median – Median case count during the previous 52 weeks.

Max: Maximum – Maximum case count during the previous 52 weeks.

\* Case counts for reporting years 2017 and 2018 are provisional and subject to change.

**Notes:**

- These are **weekly** cases of selected infectious national notifiable diseases, from the National Notifiable Diseases Surveillance System (NNDSS). NNDSS data reported by the 50 states, New York City, the District of Columbia, and the U.S. territories are collated and published weekly as numbered tables. Cases reported by state health departments to CDC for weekly publication are subject to ongoing revision of information and delayed reporting. Therefore, numbers listed in later weeks may reflect changes made to these counts as additional information becomes available. Case counts in the tables are presented as *published* each week.
